

Shared Windows Devices

Windows may be installed on shared devices, such as kiosks or lecture hall computers, for use by infrequent users like janitors or café workers

Requirements:

- Institutions must purchase Windows 10 Education E3/E5 or Microsoft 365 A3/A5 licenses for all Education Qualified Users
- Shared devices may not be assigned to a Primary User as a primary work device





Education Platform Products

What's unchanged?

- Requirement to cover all Education Qualified Users with one or more Education Platform Products
- Minimum of 1,000 Education Qualified Users

What's changed?

• Ability to mix and match User SLs in the initial order

2. Order requirements

a. Minimum order requirements for Enrollment for Education Solutions. This Enrollment allows Institution to license Products on a subscription basis across its Organization. Institution defines its Organization and can select from two different licensing options (Education Qualified UserKnowledge Workers or Students), depending on the Users it wishes to enable to use the Products-licensed.

The initial order must include Subscription Licenses for at least

- (i) One Education Platform Product for an Organization-wide Count of at least 1,000; OR
- (ii) One Education Platform Product for a Student Count of at least 1,000: OR

(ii) A mix of Education Platform Products may be ordered as described in the Product Terms-

These minimum requirements are waived if Institution has a Qualifying Enrollment. Institution must submit an order within 30 days of the effective date of the Enrollment. Microsoft may refuse to accept this Enrollment if it has a business reason for doing so.

Scenario

The School of Fine Art want to cover 20% of their faculty and staff with enhanced security, analytics, and voice capabilities

EES 2017	Initial order:	1,000 Microsoft 365 A3 Full User SLs
Enrollments	Mid-term:	200 Microsoft 365 A5 Step-up User SLs
EES 2018 Enrollments	Initial order:	800 Microsoft 365 A3 Full User SLs 200 Microsoft 365 A5 Full User SLs

Resultant licensing position in both cases:

- 1,000 Qualified Education Users
- 800 licensed for Microsoft 365 A3, 200 licensed for Microsoft 365 A5

Student Use Benefit eligibility:

• 1,000 x Microsoft 365 A3 SUB x 40 = 40,000 students licensed for Microsoft 365 A3
