

# THE MISSOURI RESEARCH AND EDUCATION NETWORK PARTICIPATION AGREEMENT

## I. TERMS OF AGREEMENT

This Agreement, for participation in a statewide consortium, is made and entered into by and between:

THE CURATORS OF THE UNIVERSITY OF MISSOURI on behalf of the Missouri Research and Education Network (hereinafter referred to as “MOREnet”), and:

## III. CONDITIONS FOR PARTICIPATION

The purpose of MOREnet is to provide collaborative networked information services to its Members in support of education, research, public service, health care and government. To that end, MOREnet and Member agree to the following:

MOREnet shall:

1. Provide service(s) to Member in accordance with [www.more.net/content/services-z](http://www.more.net/content/services-z), herein incorporated by reference, and the same may be revised from time to time.
2. Maintain the most current version of the MOREnet Service Policies ([www.more.net/content/service-policies](http://www.more.net/content/service-policies)) on its public website.

Member shall:

1. Comply with all conditions and requirements as set forth in the MOREnet Service Policies ([www.more.net/content/service-policies](http://www.more.net/content/service-policies)) as they may be amended from time to time.
2. Pay the appropriate fees as stated on the MOREnet public website as it may be amended from time to time ([www.more.net](http://www.more.net)). Member will be responsible for reviewing the MOREnet public website annually or as change notifications are issued by MOREnet.
3. Provide local hardware and software required, if any, to allow access to MOREnet services from within the Member organization.
4. Institute and maintain an acceptable use policy for its authorized users consistent with MOREnet Service Policies ([www.more.net/content/service-policies](http://www.more.net/content/service-policies)).
5. Encrypt HIPAA protected health information transmitted over MOREnet systems.

#### **IV. LIABILITY**

In no event shall The Curators of the University of Missouri, its governing board, all agents, officers, employees, successors and assigns, MOREnet or its officers become liable for any indirect, consequential, special, exemplary, or incidental damage of whatever kind and however caused, including, but not limited to time, money or goodwill arising out of the services provided by MOREnet.

Member agrees to indemnify and hold The Curators of the University of Missouri, its governing board, all agents, officers, employees, successors and assigns, MOREnet and its officers harmless from and against any claim or liability resulting from, due to, or arising out of the Member's use of MOREnet's network or services.
