CONTENT ANALYSIS

Machine learning technology blocks potentially harmful content and images in students' gmail and drive accounts.

EXPERT REVIEW

An in-house team of trained safety professionals work 24/7 to evaluate all blocked content, categorize incidents, and determine severity.

RAPID RESPONSE

In severe situations, district-appointed contacts are immediately notified by phone, even after standard business hours.

WHY ARE WE HERE?


- 749,000 students were victims of violence
- 1,000,000 students were threatened with a weapon on school property
- 876,000 students were afraid of attack or harm at school
- 250,000 students seriously considered attempting **suicide**
- 1,000,000 students were harassed, threatened, or subject to other forms of **cyberbullying**

WHY ARE WE HERE?


- Suicide is the **SECOND** leading cause of death amongst children/young adults 10-24
- More teenagers and young adults die from suicide than from cancer, heart disease, AIDS, birth defects, stroke, pneumonia, influenza, and chronic lung disease COMBINED
- Every day there are **3,041 suicide attempts** by kids in grades 9-12
- 4 out of 5 teens who attempt suicide give clear warning signs

Rate of nonfatal victimization against students ages 12-18




Teen suicide is soaring. The biggest rate increase was among black youth

AS A RESULT, EDUCATORS AND STUDENTS EXPERIENCE

- Loss of teaching time, days at school
- Increased **stress**, unhealthy school climate
- Trauma, mental health and wellness issues
- School and community violence and crime
- At worst, the loss of life



ONLINE SAFETY SURVEY

- Do you have anyone **combing through email or cloud storage** like Google Drive and OneDrive looking for inappropriate conversations, threats of violence, or obscene images?
- Are your **emails being blocked from delivery** if they contain bullying, inappropriate content, or imagery?
- If your students synced their phones to your cloud resources, would you be able to **identify inappropriate images** that may have been backed up onto a school resource?
- Can you identify a student **writing a suicide note** and sending it through email or sharing it with a friend in your cloud storage?

GAGGLE'S RECOMMENDATIONS for school-provided, student communication

Encourage usage of these platforms. Digital communication is not going away. Help them learn from their mistakes.

Visibility is key. You can **address a student's issues** when you know about it before it becomes an incident

District staff can't monitor everything, all the time. Partner with companies that can manage this for you.

Have a plan in place for when you are alerted to a situation

ENCOURAGE STUDENTS TO SPEAKUP

Provide a robust way (more than just on the website) for students to reach out pro-actively around incidents like...

- Bullying, Planned fights
- Students in crisis
- Threats of violence
- Weapons brought to school
- Other urgent situations






2018-19 SCHOOL YEAR 772 PLANS OF SUICIDE INTERCEPTED


